

## SECTION 9: JUNK VEHICLE

### Definition:

A vehicle that is incapable of operation upon public roads and has no resale value except as a source of parts, or a vehicle for which an insurance company has taken possession of, or title to, if the estimated cost of repairing the vehicle exceeds its fair market value.

### Description:

A vehicle dismantled for parts or scrapped

Operation is NOT legal under any circumstances. Vehicle can only be towed.

### Procedure:

Once the vehicle has been junked on e-MV11, destroy the ownership documents or if you prefer, stamp the title junked and place in your files. No further contact with DOT is necessary. Any questions regarding a vehicle that has been junked in error should be referred to the Research and Information Unit at (608) 266-1466.
